For what purpose and on what basis do we process personal data

Automated decision-making

How long do we keep personal data

Flexoplast BV does not store your personal data longer than is strictly necessary to achieve the goals for which your data is collected. We use the following retention periods for the following (categories) of personal data:

- Address> 12 months> For contacting us if required.
- Contact details (telephone & email)> 12 months> For making contact if desired.
- IP addresses of companies> 12 months> For making contact without obligation.
- Other personal data that you actively provide, for example with your message or question> 12 months> For the, if desired, contact us.
- Location data> 12 months> Anonymized location data is used for the analysis and improvement of our website.
- Data about your activities on our website> 12 months> Anonymized consumption data used for the analysis and improvement of our website.
- Internet browser and device type> 12 months> Anonymized usage data is used for the analysis and improvement of our website.

Sharing of personal data with third parties

Flexoplast BV only provides information to third parties if this is necessary for the execution of our agreement with you, or for legal obligations.

Cookies, or similar techniques, that we use

Flexoplast BV uses functional, analytical and tracking cookies. A cookie is a small text file that comes with the first visits to this website are stored in the browser of your computer, tablet or smartphone. Flexoplast BV used cookies with a purely technical functionality. These ensure that the website works properly and that, for example your preferred settings are remembered. These cookies are also used to make the website work properly and to be able to optimize it.

View, modify or delete data

You have the right to view, correct or delete your personal data. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom the passport), passport number and citizen service number (BSN) black. This is to protect your privacy. We respond as soon as possible, but within four weeks, at your request. Flexoplast BV would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
